## **Matters arising**

a) Highway Matters –Update on High St. widening- BT should be commencing their work during the week commencing 22<sup>nd</sup> February with South Glos to move the kerbline during the period 29 March -24 April. South Glos. are still waiting for formal confirmation from BT so these dates maybe subject to change. Parking will be suspended throughout working days, with limited parking outside working hours. South Glos. plan to letter drop all properties in this area in advance of the work but cannot do so until formal confirmation has been received from BT.
